





































Q21 Religious holidays are not an important concern for my attendance at the NARST annual meeting.







Q35 I met researchers that I did not know personally.





Q37 I feel the NARST community was receptive to my contributions.










Q40 I feel that NARST values my identity(ies).






Q41 I feel my research is valued at NARST.
